Rules Applying to Abstracts

1. Departure from these rules will result in omission of the abstract.
2. Abstracts must be typed on an "Academy Abstract Reproduction Form" in 10 point type only.
3. Each abstract must be signed by a member of The Academy that is either a coauthor or a sponsor of the abstract.
4. ABSTRACT WILL APPEAR IN THE PROGRAM OF THE ACADEMY EXACTLY AS SUBMITTED.
Do not use type that simulates script. Use 10 point type only. Single space all typing. Indent each paragraph three (3) spaces. Do not indent title. Use totally uniform spacing between lines; do not squeeze any lines.
5. Make the title brief, clearly indicating the nature of the paper.
CAPITALIZE ENTIRE TITLE. ABBREVIATIONS MUST NOT BE USED IN THE TITLE.
Subject indexes will be developed from the words used in the title, so choose them carefully.
Then state the authors, names and institutional affiliations. If no institution is involved, then state the city and state.
Underline author's names. OMIT degrees, titles, appointments, street addresses, zip codes.
DO mention support of work by a research grant.
6. Organize the body of abstract as follows;
A statement of the purpose of the study (preferably one sentence).
A statement of the methods used.
A summary of results presented in sufficient detail to support the conclusions.
A statement of the conclusions reached. (It is not satisfactory to state "The results will be discussed" or "Other data will be presented.")
Do not use subtitles, e.g., methods, results.
7. Simple tables or graphs may be included.
8. Abbreviations which are not a standard unit of measurement must be defined by placing them in parenthesis after the full word the first time they appear in the body of the abstract.
9. No paper may be presented before The Academy if it has been published or submitted for publication elsewhere. If material has been presented elsewhere, but not submitted in written form for publication, give pertinent information about the presentation so that The Academy Program Committee can make an appropriate decision about its inclusion in the program.
10. Adhere to published mailing deadline. Abstracts will not be accepted if postmarked after the Abstract Deadline.
You will be notified by the national office upon receipt of the abstract. ABSTRACTS MAY NOT BE WITHDRAWN later than one week after the abstract deadline. You will be notified upon receipt of the abstract by the National Office.
11. When your abstract is accepted, and is scheduled for presentation before The Academy, you will provide one copy of the entire manuscript, illustrations suitable for reproduction, and consent to publication signed by ALL authors. The manuscript, illustrations, and consent forms must be submitted to the Program Committee before presentation of the paper.
